UK STABBING | Mosque targeted, bricks pelted on policemen, 40 hurt

Vigil for victims turns violent

A far-right mob targeted a mosque in north-west England that saw three young girls fatally stabbed during a peaceful vigil in their memory, wounding 40 police officers in the disorder.

British Prime Minister Keir Starmer, who had earlier visited the site of Monday's brutal stabbing attack on a dance studio, condemned the "thuggery" and said the crowd had hijacked what had earlier been a peaceful vigil attended by hundreds in the centre of Southport to mourn the dead and 10 surviving stabbing victims, seven of whom were in critical condition.

"The people of Southport are reeling after the horror inflicted on them yesterday. They

deserve our support and our respect," said Starmer. "Those who have hijacked the vigil for the victims with violence and thuggery have insulted the community as it grieves. They will feel the full force of the law," he said. Police said the violent crowd that torched a police van and several cars was be-

lieved to be supporters of the English Defence League, a far-right group, and the mayhem was inspired by rumours about the identity of the teenage suspect arrested on suspicion of murder and attempted murder. "There has been much speculation and hypothesis around the status of a 17-year-

old male who is currently in police custody and some individuals are using this to bring violence and disorder to our streets," Merseyside Police Assistant Chief Constable Alex Goss said.

Police earlier said a suspect's name circulating on social media was incorrect and the boy was born in Britain.

The Liverpool Region Mosque Network posted a statement decrying the "heinous" stabbing as an attack against society that was unconnected to Islam.

"A minority of people are attempting to portray that this inhumane act is somehow related to the Muslim community," the group said on the X social media platform. "Frankly we must not let those who seek to divide us and spread hatred use this as an opportunity."

PAKISTAN

Two cops among 3 die in attack

Two policemen and a passerby were killed in when unidentified gunmen opened fire at them in northwest Pakistan's Khyber Pakhtunkhwa province in the border town of Landi Kotal in the restive tribal Khyber district bordering Afghanistan, on Wednesday, police said. The suspects managed to flee from the scene, the police said. The police contingents sealed the entire area and launched a combing operation to arrest the culprits. No militant group has claimed responsibility for the attack. Chief Minister Ali Amin Gandapur expressed grief.

New Delhi, the 24 July 2024

S.O 2938 (E)—In exercise of powers conferred by sub-section (1) of section 3A of the National Highways Act, 1956 (48 of 1956) (hereinafter referred to as the said Act), the Central Government, after being satisfied that for the public purpose, the land, the brief description of which is given in the Schedule below, is required for building (widening/Four lane with paved shoulder/Six laning etc.), maintenance, management and operation of Western Indore Bypass in the stretch of land from Km. 8.8 to Km. 20.87 (Depalpur) in the district of INDORE in the state of MADHYA PRADESH, hereby declares its intention to acquire such land.

Any person interested in the said land may, within twenty-one (21) days from the date of publication of this notification, in the Newspaper (i.e. 21 August 2024) Official Gazette, object to the use of such land for the aforesaid purpose under sub-section(1) of section 3C of the said Act. For the resolution of objections date of hearing scheduled on 22 August 2024, all the persons affected under this notification are requested to bring the clean copy of documents regarding Ownership of Land, Aadhar Card or other Identity Card, PAN Card and Bank Passbook and Submit to the SDM Depalpur Office.

Every such objection shall be made to the Competent Authority, namely, Sub Divisional Officer (Revenue), Depalpur in writing and shall set out the grounds thereof and the Competent Authority shall give the objector an opportunity of being heard, either in person or by a legal practitioner, and may, after hearing all such objections and after making such further enquiry, if any, as the Competent Authority thinks necessary, by order, either allow or disallow the objections.

Any order made by the Competent Authority under sub-section (2) of section 3C of the said Act shall be final.

Ismail Haniyeh's death a blow to Hamas

NEW YORK/TEHRAN

Ismail Haniyeh, political leader of Hamas since 2017, has been the most visible leader of the group during Israel's war in Gaza, and was key in ongoing ceasefire and hostage release negotiations.

Hamas and Iranian state media said Wednesday that the 62-year-old had been killed in the Iranian capital Tehran.



Hamas claimed Haniyeh was killed in an Israeli "strike" on his residence, while the Israeli military declined to comment

when contacted by CNN.

Haniyeh's death strikes a significant blow to Hamas at a time when tensions are flaring across the Middle East over the devastating war in Gaza, and raises fraught questions about the future of negotiations between Israel and Hamas.

As Hamas's political leader, he was a key interlocutor with international mediators during stalled hostage and ceasefire talks between Israel and

Hamas, following the group's October 7, 2023 attack on Israel.

Haniyeh was born in a refugee camp near Gaza City, and joined Hamas in the late 1980s during the First Intifada, or uprising against Israel's occupation in Gaza and the West Bank.

His parents were refugees expelled from Askalan, which later became known as the Israeli city Ashkelon.
