# HC TELLS GOVT: EITHER CANCEL OR GIVE JOBS

**COURT GIVES 3 WEEKS SAYS GOVT CANNOT HOLD RECRUITMENT PROCESS FOR A LONGER PERIOD**

The principal bench of Madhya Pradesh High Court in Jabalpur has given three weeks to the state government directing it to either cancel Patwari recruitment or restart the process. The government cannot hold recruitment process for a longer period, observed the court of Justice MS Bhatti.

The court was hearing a petition of a candidate Prayagraj Dubey, a resident of Jabalpur, challenging the ban on the Patwari recruitment. The High Court in a notice to the State Government and MP Employees Selection Board seeking reply within three-week on the matter. The next hearing is scheduled for August 21.

Earlier, Chief Minister Shrivraj Singh Chouhan had halted the appointments following alleged irregularities in the Patwari recruitment exam conducted by the Madhya Pradesh Staff Selection Board.

## 1 LAKH JOBS PROMISED, 60K APPOINTED SO FAR



### The challenge is to appoint 40,000 more in 15 days

Chief Minister Shrivraj Singh Chouhan's promise on August 15, 2022 to recruit one lakh youths in a year is going to end.

The state government has, so far, recruited 60,000 people, and it has to appoint

40,000 more within 15 days, which is a big challenge.

On Monday, when Chouhan was handing over appointment letters to the youths recruited to excise, cooperative and labour departments, he said recruitment drive was going on.

The government is committed to recruit youths on efficiency, honesty and merit. Chouhan said, adding that all of them were appointed on the grounds of merit.

"All the government schemes will be carried out through you," the Chief Minister said.

According to reports, recruitment to 8,000 posts was stopped because of Patwari examination.

Besides, the results of examinations for some posts are yet to come.

Tribal people have become the most important of all communities for the ruling party in Madhya Pradesh.

It was evident in the transfer of IAS officers late Sunday night. Mal Singh Bhaydiya was appointed divisional commissioner of Indore, since he comes of a tribal family. It has happened for the first time that an IAS officer, belonging to a tribal family, has been appointed commissioner of Indore division.

There are five districts - Dhar, Barwani, Kargone, Jabua and Alirajpur - under Indore division. All these five districts are dominated by tribal people.

The directly recruited IAS officers are generally keen on becoming commissioner of Indore division. Nevertheless, the government has counted on a promotee IAS officer because of the ensuing election.

## RATHI REMOVED FOR ERRORS IN VOTERS' LIST IN 2018 MADE COLLECTOR AGAIN

Before the polls, the Election Commission may shift Tarun Rathi who has been appointed collector. The commission removed Rathi before the assembly election in 2018, because some errors cropped up in the voters' list in Shivpuri district. In 2018, a by-election was held in Kolaras, Shivpuri. The Congress made a complaint about irregularities in the voters' list during the by-poll. Rathi delayed so much in sending reports that he could not be removed before the polling. The commission sent a



report against Rathi. So, he was removed from Shivpuri just before the assembly election in 2018.

Rathi was also shifted from Damoh after a by-election. Congress leader JP Dhanopia said the officers, whom the Election Commission found guilty of committing errors in voters' list, were again appointed collectors, which was wrong.

Dhanopia said the party would soon make a complaint to the commission about it.
