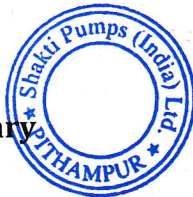



Drought threat looms...

The indifference of monsoon in Bhopal, Indore, Jabalpur, Gwalior including Bundelkhand and Malwa-Nimar has caused concern. Upper Lake (Bada Talab) of Bhopal, Kerwa and Kaliasot Dam, Kolar Dam of Sehore are also empty. Till now not even a single gate has been opened. However, meteorological department officer PK Saha said that a system was forming in the Bay of Bengal. Due to this, monsoon was expected to become active again in some districts of Madhya Pradesh.

Human trafficking gang...

Among the rescued children, 13 boys are from Shahdol, four from Umaria and two from Chhattisgarh. The ADG said that interrogation of the accused was underway.

Govt cancels three...

Mishra said, "We assigned other agencies for electronic support in investigation and then it was found that during downloading the question paper, it was leaked. CBI registers fresh FIR

The CBI on Friday registered two more separate cases pushing the number of cases to eleven on the orders of the Calcutta High Court related to violence and other offences in West Bengal. Notably, on Thursday the CBI had registered nine cases on post-poll violence. Of the 11 cases one case was of gangrape the complaint of which was registered at the Nabagram police station on May 10. Meanwhile, of the remaining FIRs three are from Gangnapur, Chapra and Kotwali in Nadia where the CBI team visited on Friday and spoke to the family members of deceased BJP cadres there and also took evidences and did videos dur-

ing their probe. CBI visited houses of Uttam Ghosh in Gangnapur who were killed on May 2 and Palash Mandal of Krishnanagar who were dragged from his house and was killed on June 14. Apart from Nadia the CBI teams had visited South 24 Parganas and also revisited deceased BJP cadre Jay Prakash Yadav's house in North 24 Parganas and have spoken to his wife. According to the deceased cadre's wife, they are still getting threats and warnings of death from local TMC cadres. "The TMC cadres are still giving us threat calls of killing the entire family. I want the investigation to run smoothly and end fast so that the culprits can get punished," said deceased BJP worker's wife.

ED attaches Khadse's assets in PMLA case

The Enforcement Directorate (ED) on Friday said it has attached assets worth Rs 5.73 crore of former Maharashtra minister and NCP leader Eknath Khadse and his family in a money laundering case. The attachment has been done in a case of "criminal misconduct by a public servant". "The attached assets include immovable properties worth Rs 4.86 crore and bank balance of Rs 86.28 lakh," the ED said. The ED is probing Khadse in an alleged land grab deal of 2016 in Pune. Khadse, 68, left the BJP to join the NCP late last year and he has been questioned by the ED in this case in the past. The case stems from a Pune policeACB FIR filed against Khadse, his wife Mandakini and son-in-law Girish Chaudhari, in April 2017. The agency claimed that alleged irregularities in the land deal caused a loss of Rs 61.25 crore to the exchequer.

Mysuru gangrape: 5 college students on police radar

The needle of suspicion in the horrific gang rape of an MBA student near Mysuru Tuesday night is now on five students studying in a college in Mysuru - four from Kerala and one from Tamil Nadu. Sources in the police said investigators had narrowed down on the active cell phone sims in the area between 7 and 8 pm when the crime reportedly took place. They found that five sims were active in the area and were later switched off. On further enquiry, the investigation team found out that the sims were that of five students. What raised further suspicion was that the five students vacated their hostel the next day of the crime and failed to appear in a term examination. The police are now on the lookout for these students and have alerted their counterparts in Kerala and Tamil Nadu. Sources said two teams from Karnataka have gone to Kerala and Tamil Nadu to take the probe further.

Sources said the culprits would be nabbed very soon. Earlier, the police had questioned all the people living in the area, including workers at

Bombay HC's bail to alleged terrorist upheld

The Supreme Court on Friday refused to entertain a plea by the NIA to re-arrest Areeb Ejaz Majeed, an alleged member of banned terrorist outfit Islamic State (IS), nabbed in November 2014 by the Mumbai ATS and then his case was handed over to the NIA.

A Bench of Justices S Abdul Nazeer and A S Bopanna declined to interfere in the Bombay High Court's decision on February 23 to uphold the bail granted to him by the trial court, despite strong pleadings by Additional

Solicitor General S V Raju on behalf of the NIA why he moving freely may trigger terrorist activities in the country. Raju claimed Majeed had returned to Mumbai to carry out blasts at the police headquarters and recruit Indians and non-residents to join the terrorist organisation and narrated how he went to Iraq in May 2014 on a pilgrimage visa but slipped out to Syria to join IS. He argued the bail is not permissible to Majeed since his case is under the UAPA.

The Bench, however, declined to entertain the central agency's petition, noting that the accused has been in

prison for more than five years and the trial court had put stringent conditions while releasing him on bail on March 17, 2020. It did not accept Raju's plea that Majid's decent behaviour can't be a ground for bail by the trial court since he had come back to India with a motive to carry out a "lone wolf attack" kind of operations.

Relying on alleged social media posts of his co-accused, the NIA had made out a case that Majid was trained in handling of weapons and firearms and he was also allegedly active in the terror activities in Iraq and Syria.
