**Sub: Qualified institutions placement of equity shares of face value Rs. 10 each (the "Equity Shares") by Shakti Pumps (India) Limited (the "Company") under the provisions of Chapter VI of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, as amended (the "SEBI ICDR Regulations") (the "Issue").**

Please note that the Treasury Committee ("Committee") has, at its meeting held today i.e. **22<sup>nd</sup> March, 2024** approved the issue and allotment of **1654944** Equity Shares of face value Rs. 10 each to eligible qualified institutional buyers at the issue price of **Rs. 1208.50/-** per Equity Share (including a premium of **Rs. 1198.50/-** per Equity Share) which is at a discount of **5%** to the floor price of **Rs. 1272.09/-** per Equity Share, aggregating to approximately **Rs. 2000** million, pursuant to the Issue in accordance with the SEBI ICDR Regulations.

The Issue opened on **19<sup>th</sup> March, 2024** and closed on **22<sup>nd</sup> March, 2024** and the same was intimated to you through our letters dated **19<sup>th</sup> March, 2024** and **22<sup>nd</sup> March, 2024** respectively.

Further, find attached herewith the list of allottees who have been allotted more than five percent (5%) of the Equity Shares offered in the Issue, marked as **Annexure A**.

Pursuant to the allotment of Equity Shares in the Issue, the paid-up equity share capital of the Company stands increased from Rs. 183,801,560/- comprising of 18,380,156 Equity Shares to Rs. 200,351,000/- comprising of 20,035,100 Equity Shares.

The shareholding pattern of the Company before and after the Issue, will be submitted along with listing application in the format specified in Regulation 31 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015.
