with proposed relocation of cheetahs from Africa to Kuno Palpur Sanctuary in Sheopur district. Indian government is in contact with South Africa for the project and is expected to sign an agreement with South Africa in this regard.

A senior forest officer told Free Press that forest minister Kunwar Vijay Shah along with RK Gupta and Additional PCCF Shubranjan Singh left for South Africa on August 22. The team will be back on August 28.

The team would also study factors related to environment, habitat, security. After returning, the team will apprise government about its findings and how they should be implemented in Kuno Palpur Sanctuary.

Another forest officer said that study team would study the pre management of wildlife (before introducing into wild). Notably, cheetahs are to be brought to Kuno Sanctuary from Namibia. Separate enclosures have been made to acclimatise cheetah in new environment. Once they adapt themselves to new environment, they will be set free in the wild.

District records 132% more rain compared to last year

Even with the break in spell of rainfall for the last three days, the district administration records show that the district has witnessed about 132 per cent more rainfall than in the last year till August 25.

According to the records, the total rainfall in the district has been recorded at 906.5 mm (35.6 inches), which is almost 15 inches more than the rainfall recorded in 2021 (390.6 mm) during the same period.

The highest rainfall in the district has been received in the Indore area, while the lowest rainfall was registered in the Mhow area (650 mm). Indore urban areas have recorded 906.5 mm rainfall, so far.

Meanwhile, the weather remained sultry on Friday with no rainfall recorded for the past three days. The rise in temperature and humidity turned the day uncomfortable. According to regional meteorological department officials, chances of heavy rainfall in Indore district are bleak till August 27.

"The monsoon trough at mean sea level now passes through centre of low pressure area over southeast Pakistan & adjoining south-west Rajasthan, Narnaul, Hardoi, Varanasi, Gaya, Purnia, Digha and thence east-southeastwards to North Bay of Bengal," Met officials said.

The maximum temperature recorded on Friday was 30 degrees Celsius, which was one degree Celsius above normal. The humidity was recorded at 69 per cent.

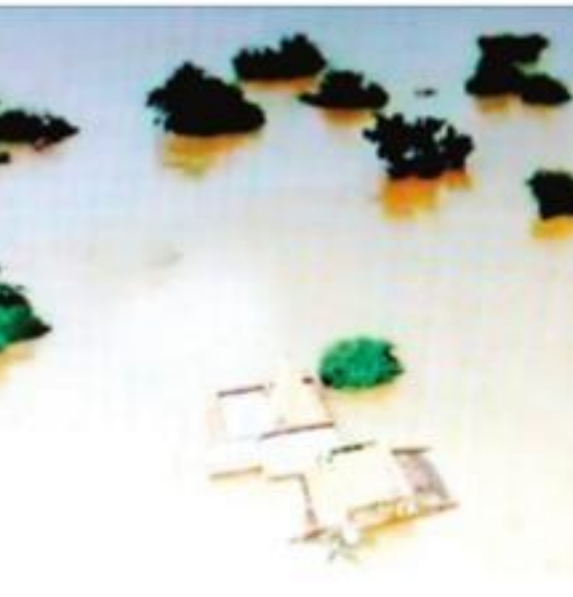
Chambal breaks 25-yr record

Like every monsoon, Chambal and Parvati rivers are in spate wreaking havoc in Morena, Bhind and Sheopur districts of Chambal division. Breaching its 25 years records, Chambal river on Thursday had touched 146.50 meters which was 8.5 mt above the danger mark which stands at 138 mt.

On Friday it was flowing at 145m at Rajghat in Morena district way above its danger mark and at 129.77 mt in Bhind. Floods this year have affected over 250 villages, this includes 200 villages in Morena, 39 in Sheopur and 25 villages in Bhind district.

Last year too, the division had witnessed floods, however, the Chambal river then had not crossed 144



meter. After 1996, once again the flood waters this year has submerged the Shiva temple, situated near the old bridge at Rajghat where the river was flowing at 145 mt mark on Friday morning. People living in around 200 villages have been rendered homeless. The flood has ruined the standing crops in

hectares in Morena district. Chief Minister Shivar Singh Chouhan has arranged two helicopters to deliver the ration to flood-affected people.

State sees 58 Covid cases

The Covid tally in Madhya Pradesh reached 10,53,192 on Friday after the detection of 58 cases, while the death toll increased by one to touch 10,770, a health official said. The positivity rate, or cases detected per 100 tests, stood at 0.8 per cent, the official added.

The recovery count increased by 134 and reached 10,41,938, leaving the state with 484 active cases, he informed. With 8,801 samples examined during the day, the number of coronavirus tests in MP went up to 2,98,70,935, he added.

A government release said 12,83,55,467 COVID-19 vaccine doses have been administered so far in the state, including 27,800 on Friday.

Coronavirus figures in MP are as follows: Total cases 10,53,192, new cases 58, death toll 10,770, recoveries 10,41,938, active cases 484 number of tests so far 2,98,70,935.
